Item 1. Operational restrictions and mandatory procedures for Special Operations flights

Supersonic flights

Always at FL360 or higher*.

Supersonic flights only inside the following areas:

Speed restrictions

Outside Special Areas the maximum speed will be MACH 0.95 above FL100 and 350KIAS below FL100 as long as it does not affect General Air Traffic.

Exceptions

All SOG are able to break those restrictions. In case the operation is performed breaking the SO regulations or disturbing GAT, the SOG will be the responsible of the operation.
